Catalina Amuedo-Dorantes is an associate professor of economics at San Diego State University. She also holds a research associate position at Fundación Centro de Estudios Andaluces, a research institute established by the Spanish government to advance economics research in Spain. She was a visiting scholar at the Institute for Research and Poverty at the University of Wisconsin, Madison. Her areas of interest include labor economics, international migration, and international finance. She has published in numerous academic journals on topics such as the informal work sector, immigrant saving, international remittances, and immigrant health care. Amuedo-Dorantes became Western Michigan University's first recipient of a doctorate in applied economics in 1998. She also holds a law degree from Universidad Nacional de Educación Distancia (Spain) and economics degrees from Universidad de Sevilla (Spain) and Université de Poitiers (France).

Edmund Balsdon conducts research on the political economy of public-good provision, including work on environmental policy and public education finance in California. He has advised San Diego County landowners of the effects of the Multiple Species Conservation Program on the local land market. He previously worked for two years with the Southwest Center for Environmental Research and Policy on a project, funded by the U.S. Environmental Protection Agency, studying environmental and land use policy in the U.S.–Mexico border region. His current research project involves the estimation of demand for publicly provided environmental goods, especially the preservation of “open space,” as reflected in local and statewide ballot measures. Balsdon received his M.A. and Ph.D. in economics from the University of California, Santa Barbara.

María del Rosío Barajas Escamilla is currently the coordinator of the master's degree in regional growth at El Colegio de la Frontera Norte (El Colef) in Tijuana, Mexico. Barajas is also a researcher at the Center for Social Studies at Colef. She has published extensively, including books and articles in professional journals on the maquiladora industry and the border economy. Barajas holds a Ph.D. in political international economics and regional economics from the University of California at Irvine and a bachelor's degree in business administration from Universidad Autónoma de Baja California.

He holds a bachelor's degree in history from Universidad Nacional de Córdoba in Argentina and a doctorate in social science from Utrecht University in Holland. Cerutti is a member of the Economic History of Northern Mexico Association.

Gustavo del Castillo Vera is a founding professor and researcher at El Colegio de la Frontera Norte (El Colef). His research combines economic anthropology and economic policy with special emphasis on North America. Del Castillo has been a visiting professor at several universities, including University of California at San Diego, University of Southern California, University of Texas, Universidad Iberoamericana (Mexico City), Universidad de Baja California (Tijuana), and others in Europe. He has been a visiting researcher at Carleton University in Canada, International Development Research Centre (Ottawa), Overseas Development Council (Washington, D.C.), and at the Center for U.S.–Mexican Studies in San Diego. He has published more than 50 papers in refereed journals and various books. At Colef, he has been editor of *Frontera Norte*, the university journal, and director of the Social Studies and U.S. Studies departments. He holds a Ph.D. in political science from the University of Texas at Austin.
